# 9:45-10:45 E.3 Proposal for Cell Phones in Livingstone Range School Division B. Toone

#### Background:

The use of cell phones among students has become ubiquitous, impacting their learning environment, social interactions, and mental health. Numerous studies from both Canada and the USA have shown the detrimental effects of excessive cell phone use on students' academic performance and mental well-being. A study by the Canadian Paediatric Society found that prolonged screen time, including cell phone use, is associated with decreased cognitive function, poor sleep quality, and increased risk of anxiety and depression among adolescents. Similarly, research conducted by the American Psychological Association has linked excessive cell phone use to decreased attention span, lower academic achievement, and heightened stress levels in students.

#### Rationale:

As governors and guardians of our students' well-being, it is imperative for the Livingstone Range School Board to take proactive measures to address this issue. By implementing a policy banning cell phones for students during school hours, we aim to create a conducive learning environment that fosters academic excellence, social engagement, and mental health resilience. By removing the distraction of cell phones, students can focus more on their studies, participate actively in classroom discussions, and develop stronger interpersonal skills through face-to-face interactions with their peers.

# Supporting Data:

• A study conducted in Canadian schools found that students who were not allowed to use cell phones during school hours demonstrated higher academic performance and reported lower levels of stress compared to their peers who had unrestricted access to cell phones.

• In the USA, schools that have implemented similar policies reported significant improvements in student behavior, reduced incidents of cyberbullying, and increased student engagement in extracurricular activities.

Community Impact:

Banning cellphones in schools not only benefits students but also positively impacts the broader community. Parents can have peace of mind knowing that their children are fully engaged in their studies without the distraction of constant notifications and social media updates. Furthermore, by promoting healthier screen habits among students, we contribute to the overall well-being of our community, fostering a generation of young individuals who are better equipped to navigate the challenges of the digital age.

Conclusion:

In light of the overwhelming evidence highlighting the negative impact of cell phone use on students' mental health and academic performance, the Livingstone Range School Board proposes the implementation of a policy banning cell phones for students during school hours. By prioritizing the well-being and academic success of our students, we take a proactive stance in shaping a healthier and more productive learning environment for all stakeholders involved.

# Rationale:

2. Efficient Start: By holding the organizational meeting in June, board members can "hit the ground running" in the fall. This ensures that crucial matters are not delayed due to the time required for orientation and acclimation.

3. Alignment with Academic Calendar: Shifting the organizational meeting to June better aligns with the academic calendar. This allows for a more cohesive approach to planning

and decision-making, as board members can strategize and coordinate initiatives in conjunction with the upcoming school year. rather than adjusting plans after the school year has commenced.

Conclusion:

Changing the date of the organizational meeting to June in non-election years offers numerous benefits, including enhanced preparation time for committee members, the ability for board members to start the new school year with efficiency, and better alignment with the academic calendar. This motion aims to optimize the effectiveness and performance of the Livingstone Range School Board for the benefit of the entire school community.
